Discussions revolved around medical marijuana, called hemp, and also other medicines which had been used by the medical profession to relieve severe seizures. Members were informed of the risks involved in many of these medications, and the help from hemp oil which had excellent results in other States at this time.

Members were shown a video of seizures by a son of Jennifer May, and how destructive these are to a child's future development physically and mentally She also discussed the current costs of medications. JoAnn Petrie discussed the use of opiates by physicians and how destructive this is to brain development. Brad Daw discussed the percentages of marijuana which is found in hemp and how the psychotropic properties of marijuana are removed from hemp because of the low percentages. Julianna Ogden opposed the use of hemp products citing addition to marijuana and its use, and also that properties in this drug have increased 50% in recent years. Laura Warburton discussed how groups can convene and push for legislation on hemp and hemp products in Utah.

#### **New Business**

### Resolution in Favor of Health Utah

The resolution was presented by Kitty Kaplan, Director and she also moved for adoption of this resolution.

Following discussions, members voted on 8 Whereas, as part of this Resolution. A motion was made on the 7<sup>th</sup> Whereas, The Healthy Utah Plan will provide insurance for 111,000 ( to insert the words low income) Utahans while supporting private insurance markets, boosting the Utah economy and maximizing flexibility for individual consumers. This amendment was voted on by the membership and passed by a 2/3 vote and the words low income were inserted into the 7<sup>th</sup> Whereas. The 8 Whereas were then approved, and members voted on Resolved, That the Women's State Legislative Council of Utah supports Governor Herbert's Healthy Utah Plan. A 2/3 vote was affirmative, and adoption of this resolution was accepted, the resolution passed.
